SUMMARY

The Event Custodian is responsible for the pre-event, event and post event cleaning. Capability of working long irregular hours for an extended period of time as dictated by the schedule of events.

ESSENTIAL DUTIES AND RESPONSIBILITIES include the following. Other duties and responsibilities may be assigned.

1. Responsible for clearing garbage, cleaning and stocking restrooms during events.
2. Ensures that all cleaning is executed in a safe and timely manner.
3. Keep all custodial closets clean, organized and stocked. Reports inventory needs and maintenance items to supervisor.
4. Keep front entrance and parking lots clear of debris.
5. Operate and maintain automatic floor scrubbers and vacuums.

SUPERVISORY RESPONSIBILITIES

1. Supervisory experience preferred but not necessary.

QUALIFICATIONS

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. 1. Must be able to follow written and oral instructions.
